It has been noted that the Central Council of Homoeopathy on its website has displayed an order indicating cut-off date of admission of students every year in BHMS Degree Course and M.D.(Hom.) Courses as 15th October of every year.

In this regard, it is informed that the it is submitted that the processing of permissions of all existing Homoeopathy Colleges and 12A applications is still under process by the Ministry and the same may not be completed in time due to the festival holidays. Therefore, the cut-off date of admission in Homoeopathy Courses (BHMS Degree Course and M.D.(Hom.) Courses) is extended till 31st October, 2016 as prevailing for Ayurveda, Siddha and Unani Colleges. The Council is requested to communicate the same to all the concerned.
