### **Agenda Item No.5.3**

**A letter dated 27.05.2019 has been received from Vice-Chancellor, Babasaheb Bhimrao Ambedkar Bihar University, regarding relax the sub Regulation 4A under the provision of 14(iii) of B.H.M.S. Regulation 1983 (amended up to March 2016).**

The Executive committee discussed the matter threadbare in respect of request of BBRA Bihar University regarding relaxation of sub Regulation 4A of BHMS regulation 1983 (amended up to 2016). The Committee decided to seek clarification with regard to delay of implementation of provision 4A, when it was notified in gazette on 14<sup>th</sup> July, 2015. It is presumed that university has not taken any examination of

any homoeopathic college under the same university for the session 2015-16, 2016-17 and 2017-18, and if so, the University may certify not conducting any examination in respect of students admitted in any homoeopathic college under it during the sessions 2015-16 to 2017-18.

The Executive Committee directed the office to complete the actions on the decisions in these minutes immediately, keeping in view of urgency of the matters.
