He introduced Dr.Chandan Kumar Das, and Dr.Bharolia Jadavjibhai Muljibhai as the new members from Tripura and Gujarat States respectively and also informed the re-election of Dr.Teli Hotu Comdir, Dr.J.K.Patel and Dr.Amiya Goswami as members in the Council. He further apprised the Council that the Hon’ble High Court of Gujarat has given the interim relief to the petitioners Dr.Pinakin N.Trivedi and Dr.Ghanshyam D.Raval that they may attend the meeting of Central Council being held on 16.8.2013. The Secretary also informed that members namely Dr.R.K.Ghosh Mondal, Dr.B.N.Prakash and Dr.P.K.Sudhir have informed their respective inability to attend this meeting of the Council.

The President, CCH addressed the Council and informed the activities undertaken after the last meeting of the Central Council of Homoeopathy. A copy of his speech is annexed with these minutes.

The new employee Kumari Kalpana, L.D.C. was introduced to the Council.

### **Agenda Item No. 51.1**

### **Confirmation of the Minutes of the 50<sup>th</sup> Meeting of the Central Council of Homoeopathy held on 19<sup>th</sup> February, 2013 at New Delhi.**

The Central Council confirmed the minutes of its last meeting as circulated.

### **Agenda Item No. 51. 2**

#### **Action taken of the Minutes of the 50<sup>th</sup> Meeting of the Central Council of Homoeopathy held on 19<sup>th</sup> February, 2013 at New Delhi.**

The Central Council noted the Action Taken Report in respect of various decisions reflected in the minutes of its last meeting.

### **Agenda Item No. 51. 3**

#### **Draft Annual Report of Central Council of Homoeopathy for the year 2012-13.**

The Central Council approved the draft Annual Report subject to the following corrections –

- (1) Under the heading of introduction, in the 5<sup>th</sup> line, the sign of “,” may be placed after the words “Central Register” and before the words “Homoeopathy Central Council Act”.
- (2) (a) Under the heading of Committees, in the 1<sup>st</sup> line, the word “entrusted” may be substituted with the words “constituted with”.  
(b) under the head of Committees, at point No. 11, the word “Excellency” may be corrected as “Excellence” (at two places).
- (3) under the heading of Meetings of Central Council and its Committees during the period under report, at S.No. 3, the word “Committee” may be inserted after the word “Education” and before the word “was”.
- (4) under the heading of Direct Registration, in the 1<sup>st</sup> line word “Certificate” may be corrected as “Certificates”.
- (5) Under the heading of Visits, at S.No.1 , in the 3<sup>rd</sup> line, the word “Homoeopathic” may be added after the word “concerning” and before the word “medical” . Further in the 3<sup>rd</sup> line the words “in Homoeopathy” may be substituted with the word “and”.
- (6) Under the heading of Workshops, at S.No. 8, the word “Uttranchal” may be corrected as “Uttrakhand”.
- (7) Under the heading of Budget, under the sub-heading of Expenditure, the figure given in front of Non-Plan as “Rs. 489.99” may be read as Rs. “518.91”. The sign of “/” may be omitted after the digits shown in front of Non-Plan and Plan respectively.

### **Agenda Item No. 51.4**

#### **Annual Accounts of the Central Council-Audit report of DGACR for the year 2012-13.**

The Central Council noted the annual accounts and the draft Audit Report of D.G.A.C.R. and also the reply sent to said draft audit report.

### **Agenda Item No. 51.5**

#### **Ministry's Letter No. Z.16011/01/2012-EP(H) dated 24.05.2013 regarding forwarding the applications received under section 12A of HCC Act, 1973 reg.**

The Central Council considered the matter and noted that a letter has been sent to Jayoti Vidhyapeeth Womens University, Rajasthan on 14.8.2013 and to Navadhar Samajik Sanstha, Dehradun on 7.8.2013 and to Vasantben N.Vyas Homoeopathic Medical College, Amreli on 11.7.2013 and 7.8.2013 which has been acknowledged but Consent of Affiliation from Uttarakhand Ayurvedic University is awaited, and Om Charitable Chikitsa Samiti, Gwalior on 11.7.2013 to which replies are still awaited. However, Department of AYUSH, Govt. of India in respect of said Om Charitable Chikitsa Samiti has informed that the proposal submitted is for re-inspection as permission was not granted to the proposed college in 2010-11, and in reference to this letter the Central Council decided that the Establishment of new Medical College (Opening of New or Higher Course of Study or Training and increase of Admission capacity by a Medical College) Regulations, 2011 does not provide for re-inspection after the application/scheme has been rejected but the applicant can move a fresh request/application in the matter, and it can be informed to the Central Govt. This factual position may be informed to the Central Govt. before 31<sup>st</sup> August, 2013 in terms of Schedule given in the Establishment of New Medical College (Opening of New or Higher Course of Study or Training and increase of Admission capacity by a Medical College) Regulations, 2011. The Council also noted no response from North Eastern Institute of Ayurveda and Homoeopathy, Shillong in respect of Central Council's letter dated 10.7.2013 and it has also not sent the Application Fees & no NOC & Consent of Affiliation have been provided, which may also be informed to the Central Govt. that this case can not be processed. The Council decided for undertaking the inspection of the applicant Dr.Ulhas Patil Homoeopathic Medical College and Hospital, Jalgaon to consider the request.

### **Agenda Item No. 51.6**

#### **Requests received under Section 12 A of HCC Act for Higher Courses.**

The Central Council considered the matter and noted that the LIC report of the Universities concerned have not been received in respect of Mahesh Bhattacharya Homoeopathic Medical College, Howrah, Govt.Homoeopathic Medical College, Bhopal, Ansushree Homoeopathic Medical College, Jabalpur and Mangilal Nirban Homoeopathic Medical College, Bikaner inspite of written requests. The Council decided that the Central Govt. may be informed and it may be inquired from the Central Govt. whether the Central Council wait for LIC report or proceed for inspection in respect of above named Colleges. In reference to Ministry's letter dated 27.6.2013 in regard to R.V.S.Homoeopathic Medical College, Coimbatore, the Central Council decided that the applicant College need to pay the Application Fees afresh as per provisions of Establishment of new Medical College (Opening of New or Higher Course of Study or Training and increase of Admission capacity by a Medical College) Regulations, 2011 (as Govt.Homoeopathic Medical College, Bangalore paid). The Central Council also noted that the NOC of the respective State

Govts. submitted by Vamanrao Ithape Homoeopathic Medical College, Sangamner and Mangilal Nirban Homoeopathic Medical College, Bikaner have not been in the format prescribed in above said Regulations as such it decided till these colleges submit NOC in the prescribed format their applications can not be processed. It further opined that as the Consent of Affiliation of Rajiv Gandhi University of Health Sciences submitted by H.K.E.Society's Homoeopathic Medical College, Gulbarga has been time barred and on the basis of it the application can not be processed, and Central Govt. may be apprised accordingly. However, the Central Council decided for inspection of D.Y.Patil Homoeopathic Medical College, Pimpri, Govt.Homoeopathic Medical College, Bangalore, D.S.Homoeopathic Medical College, Pune, White Memorial Homoeopathic Medical College, Attoor, Kanyakumari, Motiwala (National) Homoeopathic Medical College, Nashik and Dr.B.D.Jatti Homoeopathic Medical College, Dharwad for processing their applications.

### **Agenda Item No. 51.7**

#### **Request received under Section 12 A of HCC Act for increase in intake capacity.**

The Central Council noted that the NOC of State Govt. submitted by Anantrao Kanse Homoeopathic Medical College, Pune has not been in the format prescribed in Establishment of New Medical College (Opening of New or Higher Course of Study or Training and increase of Admission capacity by a Medical College) Regulations, 2011 and it also opined that on the basis of said document the application can not be processed. The Central Council noted that the report of inspection of LIC of the concerned Universities have not been submitted with the application of Father Muller Homoeopathic Medical College, Mangalore and Govt.Homoeopathic Medical College, Bhopal and further opined that the Central Govt. may be informed and its guidance may be taken as to whether the Council may proceed for inspection in absence of LIC reports or otherwise. The Council decided for inspection of D.Y.Patil Homoeopathic Medical College, Pimpri, E.B.Gadkari Homoeopathic Medical College, Kolhapur and Govt.Homoeopathic Medical College, Bangalore.

The Central Council also decided that the letter of Maharashtra Federation of Homoeopathic Medical Colleges may be referred to Education Committee for consideration.

### **Agenda Item No.51. 20**

#### **Amendment in Homoeopathy Central Council Act.**

The Central Council discussed the matter and decided to proposed amendment in Section 3(1)(b) on the analogy of amendments recently notified in Indian Medical Council Act, 1956 allowing a University of Health Sciences to elect one member for each 10 colleges of Homoeopathy as suggested below. However, the maximum limit can be kept upto 5 members if a University has 50 of above Colleges of Homoeopathy.

1. One seat upto 10 colleges
2. Two seats upto 20 colleges.
3. Three seats upto 30 colleges.
4. Four seats upto 40 colleges.
5. Five seats upto 50 and above.
